HIGHWAY 317 GRAVEL TENDER

That after receiving the recommendation of the Highway 317 Project Committee and a review of the tenders received being completed, that we award the tender to JDL Underground Ltd. for the supply and stockpile of 17,500 cubic metres of the Type 103 gravel (Bid Items 1 and 4) and 24,150 cubic metres of Type 106 gravel (Bid Items 2 and 3); total amount of the tender award for Bid Items 1-4 and 7 in the amount of \$1,503,150.00 and that the municipality exercise the conditions in Provision 1300.3 of the Standard Specifications Manual provided by the Ministry of Highways and Infrastructure, allowing for the reduction of the final quantities within 20% on the Type 106 gravel and that we authorize the Reeve and the Administrator to enter into an agreement with JDL Underground Ltd. for the supply of Highway 317 gravel according to the proposal received.
