HIGHWAY 317**Resolution No. 2018-045****Moved By: Raymond McKeary**

That we reduce the hourly rate in the Highway 317 maintenance proposal presented to the Minister of Highways and Infrastructure from \$170.00 per hour to \$140.00 per hour if the Rural Municipality of Milton No. 292 also agrees to this reduced rate.

CARRIED**HIGHWAY 317 - CONSTRUCTION****Resolution No. 2018-046****Moved By: Clinton Barr**

That the municipality present the following to the Minister of Highways & Infrastructure for improvements to Highway 317 by partial reconstruction, pulling of shoulders and clay capping:

The municipality will invest a total of \$700,000 into Highway 317 divided evenly over 4 years;

The Ministry agrees to award a maintenance contract to the municipality starting April 2018 with a rate of \$140 per hour for any municipal equipment used;

The Ministry agrees to spread gravel on Highway 317 early in 2018 to allow for the proper maintenance of the Highway;

The Ministry agrees to award the maintenance contract during construction on completed sections;

Any agreed upon maintenance contract will be for a 2 year term; after which the municipality and the Ministry agree to review the terms of the agreement.
