If an electric fence is being erected, the owner shall be responsible for the cost of the wire and the insulators."

Remove the following clause:

"If the landowner/occupant would like to upgrade the fence all extra or new material will be supplied by the landowner/occupant and the municipality will supply the labour."

And replace with the following clause:

"The owner/occupant shall be responsible for all costs relating to any difference in post size, placement, wire or gates from the minimum standard set out above."

And that the Administrator contact all landowners with previously signed agreements to notify that all costs for wire and insulators will be paid by the municipality.

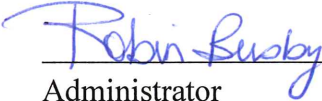
