#### A BYLAW TO PROVIDE FOR PENALITIES FOR CONTRAVENTION OF BYLAWS

The Council of the Rural Municipality of Antelope Park No. 322 of Saskatchewan enacts as follows:

#### 1. CITATION

This Bylaw may be cited as the "General Penalties Bylaw".

#### 2. GOVERNING LEGISLATION

The Municipalities Act (The Act) shall prevail in all circumstances where there might arise a conflict between The Act and the General Penalties Bylaw.

#### 3. PURPOSE

- a) Any police officer, peace officer, employee of the Rural Municipality, agent of the Rural Municipality, or any person duly authorized by Council specifically is hereby designated authority to enforce all bylaws of the Rural Municipality of Antelope Park No. 322 (the Rural Municipality).
- b) Any person who contravenes any bylaw of the Rural Municipality shall be served a Notice of Violation as set out in Schedule "A" or may be served a ticket or a summons.
- c) Subject to the provisions of Section 3(a) and 3(b), no person shall:
  - i. contravene or fail to comply with a provision of any bylaw of the Rural Municipality;
  - ii. obstruct or interfere with a police officer, a peace officer, an employee of the Rural Municipality, an agent of the Rural Municipality, or any person duly authorized by Council engaged in exercising on behalf of the Rural Municipality any of the powers conferred by a bylaw of the Rural Municipality;

- iii. destroy, pull down, alter, or interfere with any work carried out or thing done by or for the Rural Municipality pursuant to any bylaw of the Rural Municipality.
- d) Every person who contravenes a bylaw of the Rural Municipality is guilty of an offence and is liable on summary conviction with respect to the contravention of that bylaw to the penalty specified in the bylaw.
- e) Every person who contravenes a bylaw of the Rural Municipality where a bylaw does not specify a penalty is guilty of an offence and is liable on summary conviction with respect to the contravention of that bylaw, as follows:
  - i. in the case of an individual, a fine of not more than \$10,000;
  - ii. in the case of a corporation, a fine of not more than \$25,000; and
  - iii. in the case of a continuing offence, to a maximum daily fine of not more than \$2,500 for each day or part of a day during which the offence continues.
- f) If a corporation commits an offence described in this section, any officer or director of the corporation who directed, authorized, assented to, acquiesced in, or participated in the commission of the offence is guilty of the offence and liable on summary conviction to the penalties mentioned in this section in the case of individuals, whether or not the corporation has been prosecuted or convicted.

#### 4. SERVICE OF NOTICE OR TICKET

- a) Where any person has committed, or is alleged to have committed, a breach or contravention of any of the provisions of any bylaw of the Rural Municipality a notice of violation, ticket, or summons may be served on such person by a police officer, a peace officer, an employee of the Rural Municipality, an agent of the Rural Municipality, or any person duly authorized by Council. Service of such notice of violation, ticket, or summons may be made by:
  - i. by attaching the notice of violation, ticket, or summons to the vehicle, structure, or place in respect of which a breach or contravention has been committed;
  - ii. by mailing such notice of violation, ticket, or summons addressed to the registered owner of said vehicle, structure, or place; or
  - iii. by any other means of service required or allowed by law.

#### 5. PAYMENT

a) Such person served with a Notice of Violation, ticket, or summons shall pay same to the Rural Municipality of Antelope Park No. 322 within a period of ten (10) days from the service of the said Notice of Violation, ticket, or summons. If payment is made within such time and accepted, then that person shall not be liable to prosecution for the offense.

- b) Where payment of any parking violation is left outstanding beyond a ten (10) day period from the time of issuance of the Notice of Violation, the Rural Municipality shall proceed in serving the accused with a Notice of Pending Summons as per Schedule "B" as amended from time to time. If payment is still not made after thirty (30) days from the date of issuance of the Notice of Violation, the Rural Municipality shall proceed and serve the accused with a Certificate of Offence and Summons as per Schedule "C" as amended from time to time.
- c) Where payment of any violation that is not a parking violation left outstanding beyond a ten (10) day period from the time of issuance of the Notice of Violation, the Rural Municipality may proceed in serving the accused with a Notice of Pending Summons as per Schedule "B" as amended from time to time. If payment is still not made after thirty (30) days from the date of issuance of the Notice of Violation, the Rural Municipality shall proceed and serve the accused with a Certificate of Offence and Summons as per Schedule "C" as amended from time to time.
- d) Any Penalty Sum (fine and victim's surcharge) imposed as a result of a violation that is prosecuted and subsequently convicted by a court of competent jurisdiction shall be paid within fifteen (15) days of the conviction, unless such other deadline is imposed by a judge of the court. If any person fails to pay a Penalty Sum within fifteen (15) days after conviction is rendered, an additional penalty of fifty dollars (\$50) shall be added to the total outstanding amount.

#### 6. REPEAL

a) Bylaw No. 4-2004 is hereby repealed.

#### 7. COMING INTO FORCE

a) This Bylaw, and all attachments thereto, and as shall be amended from time to time shall come into force and be in effect on the final passing thereof.
