

RURAL MUNICIPALITY OF ANTELOPE PARK NO. 322

BYLAW NO. 2021-04

**A BYLAW TO REPEAL DESIGNATION AS MUNICIPAL HERITAGE
PROPERTY**

The Council of the Rural Municipality of Antelope Park No. 322 in the Province of Saskatchewan enacts as follows:

WHEREAS Sections 11 and 12 of *The Heritage Property Act* authorize the Council of a Municipality to enact bylaws to designate real property, including all buildings, features, and structures thereon, to be of heritage value; and,

WHEREAS the Council of the Rural Municipality of Antelope Park No. 322 has previously designated the property known as Hoosier United Church, legally described as Block 4 Plan G551 Extension 1 and located at the intersection of 3rd Avenue and Main Street in Hoosier, Saskatchewan as Municipal Heritage Property by Bylaw 2/91 read a third time and passed by the Council of the Rural Municipality of Antelope Park No. 322 on the 18th day of July, 1991; and,

WHEREAS Sections 17 and 18 of *The Heritage Property Act* authorize the Council of a Municipality to enact bylaws to repeal designation of real property; and,

WHEREAS the Council of the Rural Municipality of Antelope Park No. 322 has caused, not less than thirty (30) days prior to consideration of this bylaw, a Notice of Intention to Repeal to be:

- a. Served on the owners of said property;
- b. Served on the Registrar of Heritage Property; and,
- c. Published in one issue of a newspaper with general circulation in the municipality; and.

WHEREAS no Notice of Objection to the proposed repeal of designation has been served on the Council of the Rural Municipality of Antelope Park No. 322;

THEREFORE, the Council of the Rural Municipality of Antelope Park No. 322 enacts as follows:

1. There is repealed Bylaw No. 2/91 enacted on the 18th day of July, 1991 to designate the Municipal Heritage Property the real property described as:
Block 4 Plan G551 Extension 1

The reasons for the repeal being as follows:

- a. The building has deteriorated to a point that it is beyond repair

2. The Administrator is hereby authorized to:
- Discharge any interest based on the notice of designation that was registered in the Land Titles Registry; and,
 - Notify all property owners of the repeal.
 - The Administrator is hereby authorized to cause a certified copy of this bylaw to be served on the Registrar of Heritage Property.
